Where any item called for in the specifications or indicated on the drawings is not supplemented hereby, the original requirements shall remain in effect. Where any original item is amended, voided or superseded hereby, the provision of such item not specifically amended, voided or superseded shall remain in effect.

- Per Section 012100 Allowances, Article 3.1.A (page 012100-2), "Allowance No. 1 – Testing by Owner selected testing firms. The Contractor will include in Contract Sum for Base Bid an allowance of \$10,000.00 to include all costs associated with this allowance item, i.e., equipment, labor, materials, and taxes."

**Responses to Vendor's Questions:**

1. Question: Can the spoils from the excavation be left on site?  
**Response: Yes. Earthwork spoils resulting from foundation and slab subgrade preparation will be neatly placed in single stockpile on site as directed by Augusta Utilities (AUD). Areas adjacent to the building that are disturbed by construction shall be restored to match existing conditions and graded to drain water away from the building.**
2. Question: There is no space on the bid form for alternate's #1 and #2, will a new bid form be issued?

7. Question: Will temporary fencing and gates be required for this project site?

**Response: No, a site office will not be required. Temporary toilets and handwash stations will be required to accommodate personnel working on the site.**

9. Question: Please confirm Existing building roof slope where new building will be constructed (see drawings A-401 and SK-001).

**Response: The new building roof slope is to match existing building roof slope. It is estimated to be 2:12, however it is the contractor's responsibility to verify the exact slope and match it for the expansion.**

10. Question: Please confirm if main office building soffit panels are in this scope of work (see drawing SK-001).

**Response: See the Revised Bid Form attached to this Addendum 1. SK-001 is to be bid as Alternate #2 for this project.**

11. Question: What is the estimated construction budget?

**Response: There is a budget, but it will not be disclosed.**
